Please read the registration details below, enrolment in our courses implies their acceptance.

Enrolment

By enrolling, you accept the contract and travel terms and conditions of **A2B Immersions**:

- △ Be over 18 at the beginning of the course
- Accept the quote provided by **A2B Immersions**,
- △ Send us the completed enrolment form with a passport photo
- △Upon confirmation pay a deposit of EUR 300
- △ The balance is due no later than 3 weeks prior to the course start.
- Accommodation and meals are to be paid directly to the hotel chosen, following its terms and conditions.

Confirmation

Once we have received your enrolment, we will provide confirmation within 10 days.

Payment of the course

The deposit amount of EUR 300 is to be paid following the reception of the enrolment confirmation and balance is due no later than 3 weeks prior to the course start. Payment to **A2B Immersions** in Euros on the following bank account:

Visa

If you require a visa for travel in France, following receipt of the enrollment confirmation and the total payment of the course (course and registration fees), we will send you an invoice and a certificate of registration.

Arrival and departure

In order to organize your transfer, we invite you communicate as soon as possible the time and dates of your arrival and departure including any flight or train details

Insurance

You are obliged to be covered against the risks of illness and accidents abroad. It is necessary to announce your departure abroad to your health organization (or additional mutual insurance company).

Cancellation

Any cancellation must be notified by registered letter. If the cancellation occurs less than 21 days prior to your departure, EUR 300 is invoiced to you.

If your cancellation occurs less than 7 days prior to your departure, EUR 500 is invoiced to you. Following your departure or in case of an early return 100% of the course is invoiced.

Accommodation / Meals

Registrants are responsible to follow all the terms and conditions of the hotel and are subject to its conditions of cancellation (detailed terms and conditions of cancellation on request).

A2B Immersions may cancel a program in the case of unforeseeable circumstances such as, a strike, unrest or other restrictive reasons or if the number of participant is inferior to 6. The total amount paid for the course is immediately returned and we will recommend an alternate program.

Early withdrawal

In case of an early withdrawal from the course, no payment will be refunded. If you do not attend a class you shall not receive a refund, nor any other compensation.

Complaints

Any complaint must be made directly to **A2B Immersions** at the time it is recognized and during the time of your stay. If the problem cannot be solved directly you may submit your complaint within 30 days following the completion date. Any complaint made after this deadline is inadmissible.

In case of dispute between the parties, the dispute, according to its qualification, will be considered whether by the County Court of Montpellier or the High Court of Montpellier.
